Weekly News Wrap

Greater China

- HKEX-listed Yingde Gases Group, the industrial gas supplier controlled by the **Sun Zhongguo** family, announced on 30 September that its China subsidiary Hunan Yingde has gained approval from the China Securities Regulatory Commission for the issue of up to CNY 980m (USD 154m) five-year corporate bonds. The undetermined coupon rate is between 4% and 6%. The proceeds will be used for capex, loan repayment and construction of projects. Capital Profile covers two members of the Sun Zhongguo family and five companies.
- HKEX-listed Yuzhou Properties, controlled by the **Lin Long'an** family, has exercised its option to call its USD 250m 11.75% senior notes due-2017 at 105.875%, reported Debtwire on 30 September, citing the company and bondholders. The home-building will use its internal resources to fund the early redemption. Capital Profile covers 14 members of the Lin Long'an family and 24 companies.
- Fosun International, the HKEX-listed conglomerate controlled by **Guo Guangchang**, may be interested in acquiring the 60% stake in the French airport of Lyon from the government, reported Le Figaro on 30 September, citing an expert. The airport could be valued at EUR 900m (USD 1bn). The company may also eye Red Seal Natural, the New Zealand-based food and vitamins company, according to Mergermarket on 29 September. Capital Profile covers three members of the Guo Guangchang family and 59 companies.
- HKEX-listed Evergrande Real Estate, controlled by **Xu Jiayin**, plans to raise up to CNY 20bn (USD 3.14bn) via a non-public five-year bond issue in mid-October, reported the Hong Kong Economic Times on 30 September, citing an undisclosed market source. Capital Profile cover five members of the Xu Jiayin family and 21 companies.
- Hong Kong tycoon **Li Ka-shing** in a press release on 30 September, denied the allegations that he was “unpatriotic” and “withdrawing” from China. The release reiterated that Li's CK Hutchison group will continue to invest in mainland China. Capital Profile covers six members of the Li Ka-shing family and 45 companies.

Indonesia

- Indofood Sukses Makmur, the IDX-listed Indonesian foods company of the **Salim** family, plans to hedge 20% of its USD 1.2bn net debt exposure in 4Q15, Bisnis Indonesia reported on 1 October, citing director Werianty Stiawan. The company is looking at other means to converting its USD debt exposure to IDR.
- The family's PSE-listed infrastructure group, Metro Pacific Investments Corporation, is planning the acquisition of approximately 12 hospitals in the next four years, according to an unsourced report in the Business World on the same day. This followed MPI's announcement of acquiring the remaining 65.18% stake in Davao Doctors Hospital. Capital Profile covers 35 members of the Salim family and 54 companies.
- Bumi Resources, the distressed coal miner backed by the **Bakrie** family, will meet an ad hoc committee of senior bondholders in London early next week regarding its debt restructuring proposal in an attempt to reach a consensus, reported sister publication Debtwire on 30 September. Bumi aims to reach a deal with creditors by 24 October when its Singapore court-granted protection expires. A revised restructuring plan presented by Bumi on 28 September, was rejected by ad hoc committees of senior bondholders and convertible bondholders. Its senior lenders were also not in favor of the proposal, according to Debtwire. Capital Profile covers 28 members of the Bakrie family and 41 companies.
- J Resources Asia Pasifik, the IDX-listed miner controlled by the **Johan Lensa** family, is in talks with lenders to refinance its USD 275m syndicated loan due in 2017, according to a 29 September stock exchange announcement. Capital Profile covers four members of the Johan Lensa family and 17 companies.

Malaysia
